

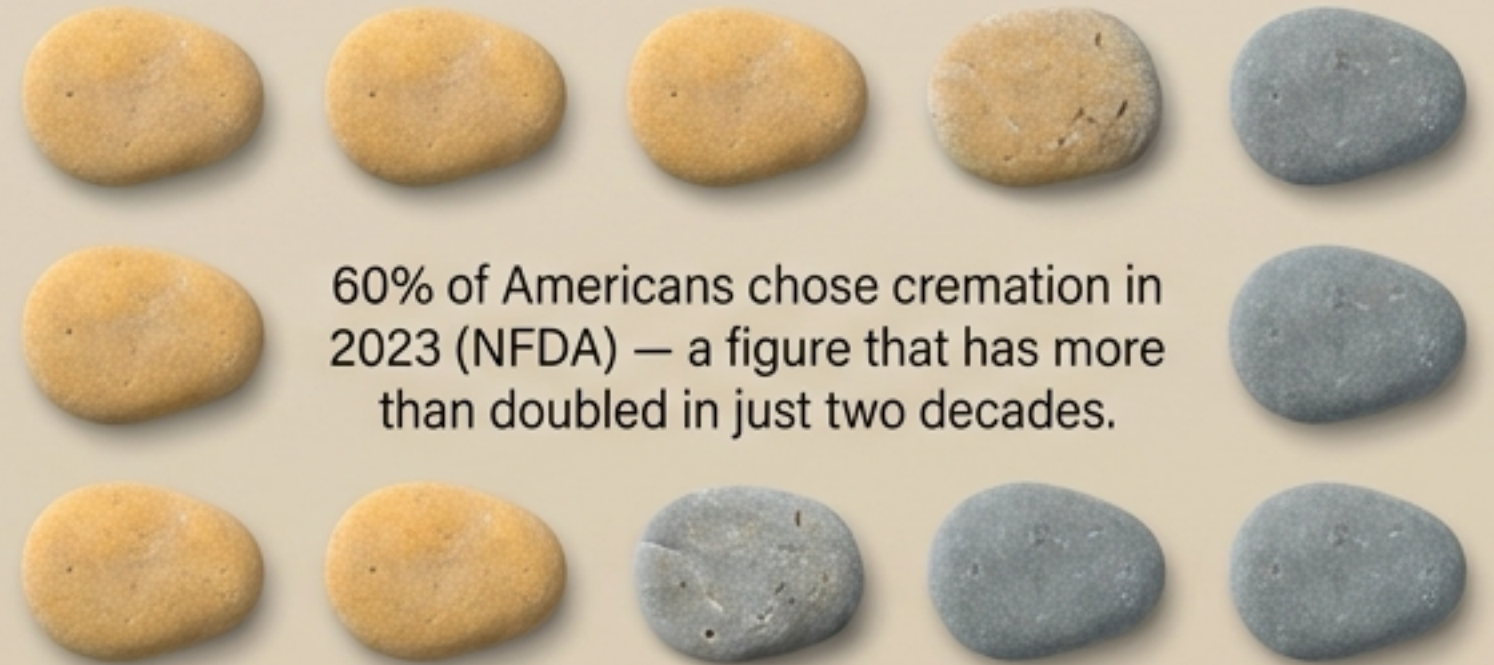

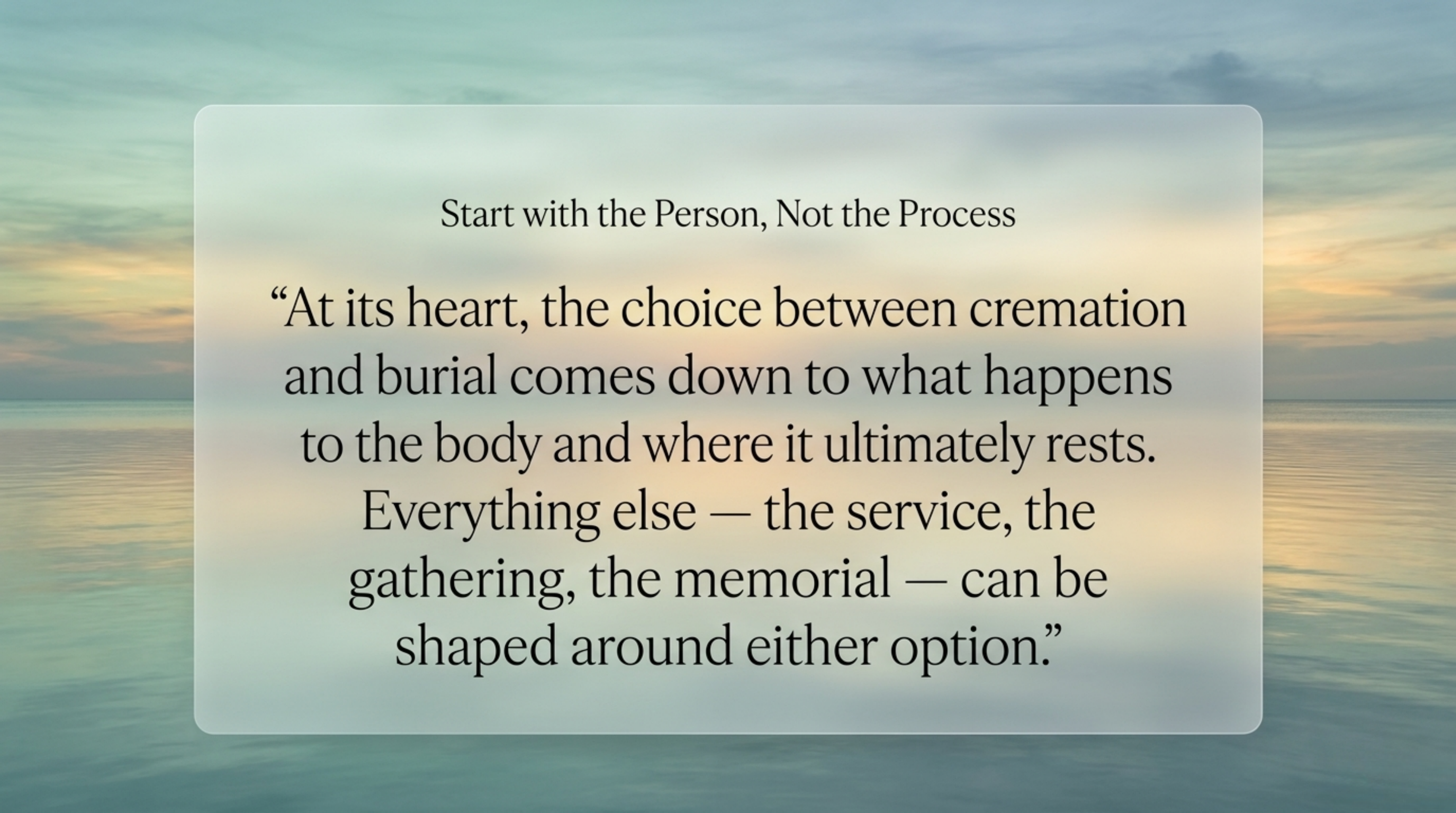


# You Are Not Alone in the Confusion

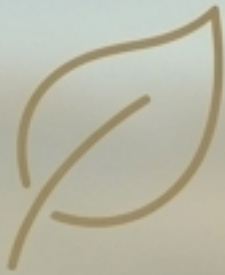
Start with the Person, Not the Process

# Two Paths Accompanied by Equal Dignity

## Simple (Direct) Cremation



Direct transport to the crematory without a prior formal viewing.

Ashes are typically returned within a few days.

Offers ultimate flexibility to hold a deeply personal celebration of life on your own timeline.

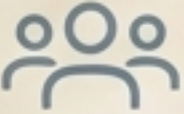
## Traditional Burial



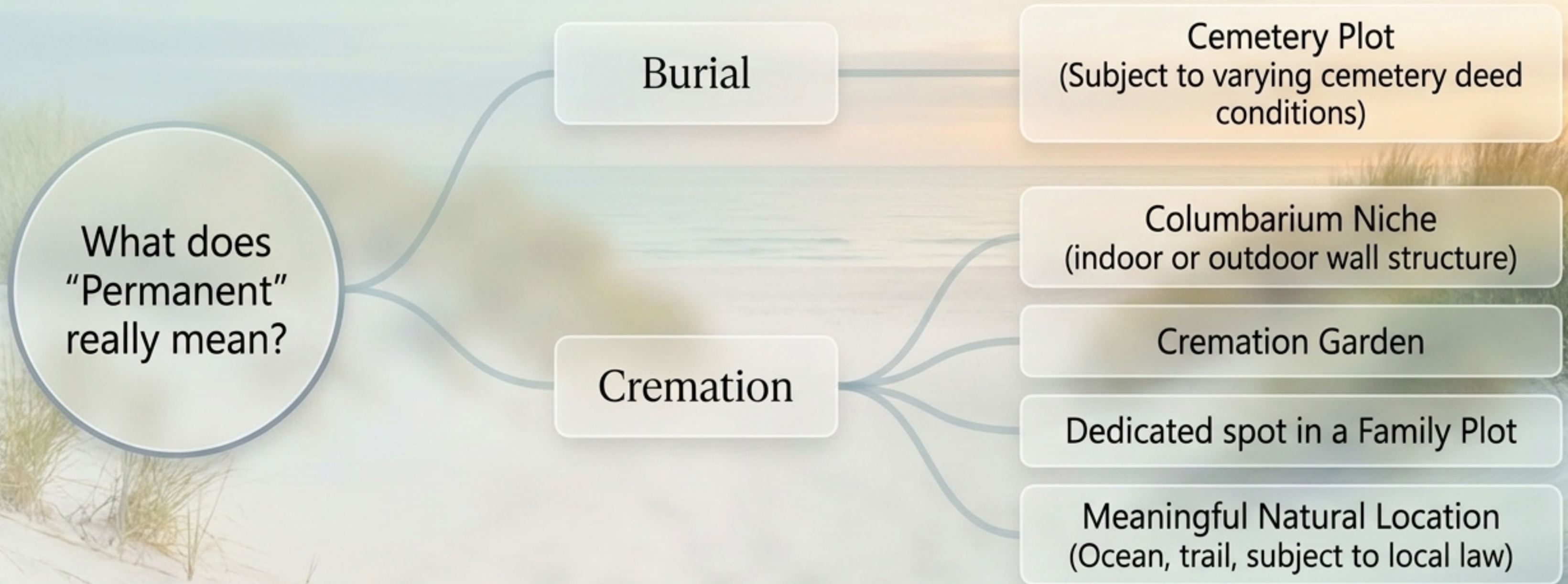
Involves preparation of the body, followed by a visitation or funeral service.

Interment in a cemetery provides a fixed, physical place for families to visit, offering a sense of continuity that matters deeply to many.

# Comparing the Practical Realities

|  Required Elements | Urn. (Scattering or niche placements are optional choices).  | Burial plot, grave marker, and a vault or grave liner (required by most cemeteries, though not by law). |

# Reimagining a Permanent Resting Place



Cremation does not mean the absence of a permanent place. By scattering or dividing ashes, it can actually create multiple meaningful places for a family to visit.

# Separating Legal Mandates from Industry Myths

Myth: Embalming is legally required.

**Truth:** It is almost never legally required. While there are narrow exceptions (like certain state-line transports), embalming is a choice, not a mandate.

Myth: A viewing is impossible without embalming.

**Truth:** Refrigeration can safely preserve the body for a short-period visitation in many circumstances. We will always discuss what is realistic for your specific situation.

# Protecting Your Emotional and Financial Wellbeing

Myth: Cremation means you can't have a traditional funeral service.



**Truth: A full funeral service, with the body present, can absolutely take place before cremation. Many families choose exactly this path.**

Myth: The most expensive option is the most respectful one.



**Truth: Cost has no relationship to love or respect. A simple, meaningful service reflects a life just as beautifully as an elaborate one.**



## Your Rights Under the FTC Funeral Rule

The Federal Trade Commission has protected consumers since 1984. We want you to know your rights before making any decisions.



**Total Transparency:** You have the right to an itemized General Price List upon request, before any arrangements begin.



**No Forced Packages:** You are never legally obligated to purchase a package. You can build a service item by item.



**Independent Casket Purchases:** You have the right to purchase a casket elsewhere. Funeral homes must accept it and cannot charge a handling fee.
